



## Music Tuition at Perins 2025/26

### TERMS AND CONDITIONS

1. Each yr7-10 pupil will be offered a minimum of 30 lessons in a school year at the cost of £330 per instrument per year payable in advance. In cases where the tutor has been unable to offer the minimum number of lessons then the tuition fee will be reimbursed at a pro rata rate at the end of the school year.
2. Each yr11 student will finish music lessons at May half term and will be offered a minimum of 25 lessons over the year at the cost of £275 per instrument per year payable in advance. In cases where the tutor has been unable to offer the minimum number of lessons then the tuition fee will be reimbursed at a pro rata rate at the end of the school year.
3. Fees should be paid online via Scopay by the date stated in the documentation accompanying these terms and conditions. If you are having difficulties paying the fees by the due date, please contact the Finance Team to discuss. If payment is not received by the due date you may lose your lessons.
4. Unless we can re-sell your lesson slot to another student, there will be no refunds if a student decides to give up lessons during the year, as Perins is contracted to pay the tutors for the full year once they have been booked. Where possible, we will offer a change of instrument if requested, although this will be dependent upon the availability of suitable lesson slots.
5. Pupils may be able to change their lesson time if they have a test/exam or medical appointment scheduled, but they must provide a note from the subject teacher/parent in their diary and give at least one week's notice. Tutors will do their best to accommodate the pupil in another group, but this cannot be guaranteed.
6. Lessons will be a minimum of 20 minutes and will take place during the school day and are shared with a maximum of three other students from any year group. Pupils will come out of subject lessons to attend their music tuition which will operate on a rotating timetable to minimise, where possible, students repeatedly missing the same lesson. Timetables will be on display on Ibsen's notice board, in a public area.
